Limitation of the period of employment of Consultants/Advisors appointed to Ministries


A limited number of Consultants/Advisors had been appointed, with the approval of the Cabinet of Ministers to provide expertise required by the Hon. Ministers and the relevant Ministries in the implementation of various programmes of the Government, under the Ministries.

02. With the declaration of the Presidential Election 2010 and the intended appointment of the new Cabinet of Ministers after the Parliamentary Election 2010, duration of such appointments made after January 2010 had been limited for a period up to 30th April 2010. However, it has been observed that the periods of employment of certain Consultants/Advisors appointed prior to January 2010 continue beyond 30th April 2010.

03. A new Cabinet of Ministers has now been appointed and the number of Ministries has also been reduced. Accordingly, the newly appointed Ministers have to assess the need for appointing Consultants/Advisors for the subjects and functions assigned to the new Ministries. As such, His Excellency the President is of the view that the services of the Consultants/Advisors presently serving in those Ministries will not be required beyond 30th April 2010.

04. In the circumstances, you are kindly requested to terminate with effect from 30th April 2010, the services of the Consultants/Advisors under your Ministry, whose period of employment continues beyond that day, complying with the requirements of the Letter of Appointment. Those who have been appointed as Consultants/Advisors on secondment basis, should be reverted back to the relevant Institutions with effect from 01st May 2010. You are kindly requested to send a list of Consultants/Advisors whose services were discontinued on the above basis, by FAX (to Fax No.2323730) to reach me on or before 07th May 2010.

05. Please substitute this letter in place my letter dated 30th April 2010 which was transmitted to you by Fax.
